**ACTION TAKEN:** On 04/19/13, I received the call detail records for telephone number 203 364-9879 dated 01/01/2012 through 12/14/2013 from AT&T as a result of a search warrant. The information was previously entered into evidence as Exhibit # 367. A working copy was made and is attached to this report.

Upon review of the records, I noticed that there wasn't a large amount of activity from 01/02/2012 to 10/01/12. According to the records, the telephone number 203 364-9879 was listed as the originating number on only two occasions and on all other calls it was listed as the terminating number. The contacts that made a connection are indicated by the number "0" in the "Ans Ind" column. A number "1" indicates that no connection was made. On only two occasions did the number 203 364-9879 actually make a connection. That connection was made in the following manner:

On 01/23/12, phone number 203 364-9879 connected to telephone number 800 504-5897 @ 1535 hours for one (1) minute and one (1) second and again @ 1535 hours for four (4) minutes and forty-six (46) seconds. Telephone number 800 504-5897 belongs to Optics Planet.com, a company that specializes in selling binoculars, rifle scopes, military style clothing and sporting goods.

On 08/16/13, I spoke with Colleen Savage, Custodian of records for AT&T to ask for her assistance in reading the records. I was unable to obtain subscriber information on some of the telephone numbers listed. Some telephone numbers were associated with numerous people. Savage informed me that it appears that there were two telephone numbers associated with 36 Yogananda Street, Newtown, CT. The 203 364-9879 number appears to be used for the computer. Contained within the information in the records, are six digit numbers separated by a hyphen (i.e.; 706-349). Savage informed me that these are characterized as voice over IP numbers and are usually associated with the number that appears before it. Savage also informed me that it appears that the person who was using the line pretty much did not accept a lot of incoming contacts as seen by the number of "1s" (unanswered) listed in the "Ans Ind" column. Overall, there is nothing remarkable to report about this telephone number
