Incident Summary:

On12/14/2012 at 0941 hours State Police personnel were assigned to respond to the Sandy Hook Elementary School for a reported active shooter situation. Upon arrival State Police personnel discovered multiple persons deceased, including twenty (20) children, six (6) school personnel, and what was later determined to be the sole assailant. Detectives from the Central District Major Crime Squad were subsequently assigned to assist the Western District Major Crime Squad with the investigation into this incident.

Action Taken:

During the initial stages of this investigation, all vehicles parked at the Sandy Hook Elementary School were identified by searching each vehicle registration plate through COLLECT. Each vehicle was then listed on a Return of Vehicle form that was generated by Det. Gogluicci (CDMCS). These forms included vehicle information, location of vehicle, owner information, and a vehicle released to section, as well as a signature line for the person claiming the vehicle and the Trooper releasing the vehicle.

Once the vehicles were identified, detectives were assigned to contact the owners of the vehicles in attempt to have them remove their vehicles from the school parking lot. Upon the arrival of the owners (or other designee) to the school, their contact information was noted on the form. They, along



with the releasing Trooper, were then required to sign the Return form.

On several occasions teachers (or other property owners) who arrived at the school to retrieve their vehicle also requested personal belongings from their classroom. When this occurred a detective would retrieve those belongings and list them on the back of the Return of Vehicle form, with an accompaning signature from the property owner.

There were three separate instances where an Inventory of Property Seized Without a Search Warrant form (JD-CR-18) was completed for property retrieved from the school and turned over to the appropriate person (see attached).
