- Emails between Nancy and Dr. King regarding his evaluation of the shooter and possible future treatments.

- PPT evaluation from Newtown High School Psychologist Michael Ridley (dated 12/2006) stemming from an evaluation conducted by Dr. Fox on 09/11/05. (See supplemental report)

- Newtown High School report card from 2nd Quarter (11/07--01/08) and 3rd Quarter (01/08--04/08)
