REPORT: SEARCH WARRANT RESULTS FOR LANZA HOME TELEPHONE (203) 426-8167

ACTION TAKEN: On 04/19/13 I received the call detail report electronically from AT&T for Nancy Lanza's home telephone line, which was obtained through a search warrant (SEE ATTACHED 91 PAGE REPORT). The electronic records were copied to a CD and entered into evidence on 05/01/13 as Exhibit # 366 (SEE EXHIBIT REPORT). Working copies of that CD were made and are attached to this report (SEE ATTACHED CDs).

I created an amended version of the report (SEE ATTACHED) in which I took known telephone numbers that I obtained from Nancy Lanza's cellular phone contact list, Nancy Lanza's telephone/address book, and an Internet search, and imputed them into the document to replace the original telephone number listed. The amended version of the report covers a period of approximately 30 days (11/12/12 to 12/14/12). Any remaining telephone numbers listed were found to have no identifying information associated with that number. In performing a cursory search of the records, I did not find anything remarkable to report.

On the date of 12-14-12, I noticed several telephone calls that were made from the home to telephone number (203) 797-0615, beginning at 1350 hours. I called Colleen Savage, Custodian of records for AT&T and she explained to me that the number is a voicemail hub number. Savage stated that what happens is a caller calls the house and receives a voicemail. The number called will then automatically call out to the voicemail and therefore it registers as a call being made from the house. Savage stated that it is similar to a call forwarding system. When I called the telephone number, an automated voice asked me for the telephone number and a PIN number. I was satisfied that on 12-14-12, no telephone calls were made from 36 Yogananda Street, Newtown, CT.


