#### SUPPLEMENTAL REPORT: ADDENDUM TO GPS

### ACTION TAKEN:

On August 12th, 2013 at approximately 1030 hours, I drove to International Drive/Eagle Rd. in Danbury, CT to determine the reason the GPS would be positioned there during early morning times from 2400 hours to 0516 hours on the following dates of, 04/25/12, 04/28/12, 05/09/12, 05/10/12, 05/12/12, 05/19/12, 06/03/12, 06/03/12, 06/17/12. Upon arrival, I found that the plaza has three businesses, Lowe's, Best Buy and Loews Theatres.

Within Loews Theatres (AMC) I spoke with Joe Andrews, Maintenance and Repair. Andrews verbally stated that the last movie showing would be over at 0230 hours and the doors to the theatre are locked at 0245 hours. I informed Andrews of my reason for the visit and inquired if he remembers seeing the shooter at the theatre. At this point, I provided Andrews with a DMV blow back picture of the shooter and his mother. Andrews replied that he has never seen the shooter but has seen his mother. Because of the early morning times that the GPS was positioned in the parking lot I inquired why a person would be here and he replied that there is none. I then spoke with Corey Davidson, Supervisor. Corey stated that he recognized the shooter and has seen him in the theatre pretty much every weekend for the past four years. Davidson further stated that the shooter always played, which was "DDR" Dance Dance Revolution. I then provided the DMV blowbacks to Davidson which he stated "that is the person I've seen here." Davidson further stated that another theatre employee, Darren Price, has had interaction with the shooter (Refer to Davidson's written statement.)

On August 15th, 2013, Det. Downs and I met with Darren Price, within Loews Theatres. Price stated that sometime in April of 2011 was the first time that he met the shooter, everybody referred to him as "DDR guy." Price interacted with the shooter by playing Dance Dance Revolution (DDR), which is a game that can be played simultaneously with another person. The shooter played the game so much that Price had to put a token on the machine indicating that he wanted to play. The shooter then asked, "Are you going to play?", which Price stated "yes." At this time, Price asked the shooter what his name was and he didn't reply, which made Price feel awkward. On occasion, Price observed the shooter playing "DDR" with **04** (ph.) (LNU), whom everyone referred to as "DDR Girl" and an Asian boy (Detectives believe to be **04**.) The shooter would go to the theatre every Friday thru Sunday from 2pm to 6pm, playing for about 4 hours.

In August 2011, the shooter continued coming every Friday thru Sunday and started playing the game for about 8 to 10 hours.

Sometime in 2011, there was a large snowstorm and he hadn't seen the shooter for about month after that. According to Price, it was either before or after the snowstorm that he interacted with the shooter and that's when he formally told Price his first name.

The last interaction Price had with the shooter was in August or September of 2012.

Prior to this interview, Price was shown two photographs of which he immediately identified the shooter as "DDR guy." He did not recognize Nancy Lanza (Refer to Price's statement for details.)


I then proceeded to the Best Buy and spoke with James Melville, Channel Sales Manager. Melville stated that he has never seen the shooter within the store. Melville also stated that he has never observed anyone in the parking lot during the early morning hours.

I then spoke with Lowe's Store Manager, Angelo (LNU.) Angelo stated that he has never seen the shooter within the store. Furthermore, he has never seen anyone within the parking lot during the early morning hours.

I then spoke with Det. Lt. Michaels of the Danbury Police Department, Det. Lt. Michaels provided me with contact information for sergeants who

frequently patrol the area of the movie theatre. After speaking with the sergeants they stated that they never have encountered the shooter within the area, nor has any of their officers. There appears to be no reason why the shooter would be in that area.

Furthermore, I contacted the security agency (Force 1) whom patrols Commerce Park which is located in the same vicinity as International Drive/Eagle Rd. After speaking with the supervisors, I was informed that the International Drive/Eagle Rd. Plaza does not have contracted security at the plaza. I was also informed that in the morning hours it is common for teenagers to race fast cars on Thursday, Friday and Saturday.

In conclusion, I am unable to find a reason why the GPS would be located at the plaza during the early morning hours.
