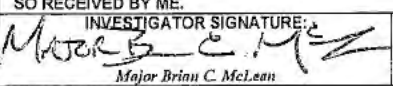

Summary of Incident: During the Newtown investigation and crime scene processing at Sandy Hook Elementary School, School Superintendent Janet Robinson requested that investigators secure petty cash from the kitchen area of the school. Ms. Robinson asked that the money be turned over to her assistant, Dr. Linda Gejda once secured.

Action Taken: On December 17, 2013, a formal request to secure petty cash from the Sandy Hook Elementary School kitchen was made by School Superintendent Janet Robinson. Chief Montgomery (Brookfield PD) forwarded this request to this writer who then met with Sergeant Jeff Covello of the WDMCS. Crime scene processing by CSP investigators was underway at the school at this time. At 1850 hours, Sergeant Covello and this writer went to the kitchen area of the school and located a clear plastic bag containing paperwork and US currency amounting to \$428.45. The plastic bag was secured, photographed and inventoried. A JD-CR-18 'PD Use Only' was completed documenting the contents of the bag (see attached).

On December 18, 2013, the secured petty cash and inventory paperwork was turned over to Lieutenant Clanford Pierce of the Connecticut State Police who was instructed to meet with Dr. Linda Gejda. On this same date, Lt. Pierce met with Dr. Gejda who took possession of the school property and signed the JD-CR-18 form.

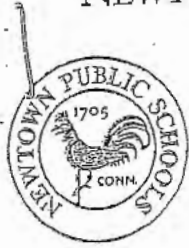
