EVIDENCE EXAMINATION - 36 YOGANANDA STREET

The below listed items were seized by the Connecticut State Police from 36 Yogananda Street in Newtown pursuant to a Connecticut Search and Seizure warrant in connection with the investigation into the mass murder at Sandy Hook Elementary School on 12/14/2012. These items were then turned over to the FBI for forensic examination, and as a result each item bears a Connecticut State Police exhibit number and an FBI exhibit number, as well as the State Police case number each item was seized under.

The items were returned to the Connecticut State Police on 07/11/2013, at which time Danbury State's Attorney Stephen Sedensky requested that the below listed items be re-examined to the extent possible by members of the Western District Major Crime Squad to determine if any item contained evidence relevant to the school shooting. For the purposes of this examination and subsequent reporting, the items were divided into three groups:


1) The computers and related storage devices (CSP exhibit numbers 4, 24, 31 and 44 under CFS-12-00705354 and exhibit numbers 601 and 602A under CFS-12-00704559) were examined under a separate report titled "REVIEW OF ELECTRONIC EVIDENCE."

2) The three garning consoles (CSP exhibit numbers 2, 12 and 43 under CFS-12-00705354) were submitted to the Connecticut Forensic Laboratory on 07/25/2013 by Det. Flynn #644 for analysis. The results of that examination are detailed under a separate report titled "GAMING CONSOLES EXAMINATION."

3) The remaining exhibits were examined as detailed below in this report.
