DATE AND TIME OF INVESTIGATION:

Friday, December 14, 2012, at approximately 0930 hours

SUMMARY OF INCIDENT:

On the above mentioned date and time members of the Connecticut State Police, along with numerous other municipal and federal law enforcement agencies responded to an active shooter call at the Sandy Hook Elementary School, located at 12 Dickinson Drive, Newtown, Connecticut.

ACTION TAKEN:

On Friday, December 14th, 2012 between 1235 and 1302 hours, I Detective Flockhart #2053, interviewed [REDACTED] 04, 03 [REDACTED] is a 04 grade teacher at the school [REDACTED] 04 [REDACTED] provided this writer with the attached sworn written statement. The following is a breakdown of the statement but is not inclusive to everything [REDACTED] 04 [REDACTED] stated on the day of the incident: "I am a 04 grade teacher and my room number is 04. It was about 9:30, I was reading a story to my kids in preparation to making ginger bread houses. We heard the loud speaker come on with muffled and confusing sounds. Then I heard something that sounded like a bunch of metal things had been dropped. [REDACTED] 04 [REDACTED] grade teacher from the next door stuck her head in through the kitchen that connects our room, and shouted, close the door and go on lockdown. At the same time a parent of one of my kids [REDACTED] 04 [REDACTED] came into my room and pulled the door behind him. He [REDACTED] 04 [REDACTED] was here for the ginger bread project which was due to start at 9:45. I sent all the kids and [REDACTED] 04 [REDACTED] into our cubby area, put down the shades, and covered the window of my classroom door. Then I joined the kids on the floor of the cubby area. There continued to be noises over the intercom. People ran by the classroom outside. I did not see who. I read a story to the kids and played a spelling game. Then the police arrived and ushered out".
