grade teacher	from the next door	stuck her head in th	rough the kitchen that	connects our room	, and shouted, close the door and
go on lockdown. At the same time	a parent of one of	my kids 04	came into my room an	d pulled the door b	ehind him. He ld 04 m was here
for the ginger bread project which	was due to start at	9:45. I sent all the	kids and 04 into c	our cubby area, put	down the shades, and covered the
window of my classroom door. Th	en I joined the kids	on the floor of the	cubby area. There con	tinued to be noises	over the intercorn. People ran by
