**Incident Summary:**  
 On 12/14/2012 at 0941 hrs. State Police personnel were assigned to respond to the Sandy Hook Elementary School for a reported active shooter situation. Upon arrival State Police personnel discovered multiple persons deceased, including twenty (20) children, six (6) school personnel, and what was later determined to be the sole assailant. Detectives from the Central District Major Crime Squad were subsequently assigned to assist the

On 12/14/2012 this investigator and Trooper James Nolting #1022 (Central District Major Crime Detective) were assigned to locate [REDACTED] 04 an employee at Sandy Hook Elementary School.

Upon arrival to [REDACTED] 04 (at approximately 2130 hours), we spoke with [REDACTED] 04, 03 [REDACTED]). [REDACTED] 04 who is also employed by Sandy Hook Elementary, had previously provided a statement to State Police investigators regarding this incident.

According to [REDACTED] 03, 04 [REDACTED] is employed by Sandy Hook Elementary as [REDACTED] 04 [REDACTED] stated that she had spoken to [REDACTED] 04 regarding the incident and that he had not observed anything of investigative value. At the time of our arrival [REDACTED] 04 had gone to sleep as he was still upset about this incident.

[REDACTED] 04 stated that [REDACTED] 04 was inside the library at the time of this incident. She stated that he had hid in a closet at the time of the incident and that he had exited the school from the rear of the building after the police had arrived. She stated that he did not see the assailant, nor did he see any victims [REDACTED] 04 reiterated that [REDACTED] 03, 04 [REDACTED]. She stated that she would contact this investigator if [REDACTED] 04 provided any pertinent details.
