

PURPOSE OF INTERVIEW:

O4 is currently employed as **O4** at the Sandy Hook Elementary School (S.H.E.S.) located at #12 Dickinson Drive in Newtown, Connecticut. Earlier in the day, State Police personnel responded to the school for a reported active shooter situation. Upon arrival, multiple persons were discovered deceased, including twenty (20) children, six (6) school personnel, and what was later determined to be the lone male assailant, Adam Lanza. **O4** was one of the areas identified to have sustained casualties.

Around the beginning of the week, possibly Tuesday (12/11/2012) or Wednesday (12/12/2012), 04 was speaking with Vicki Soto, 04 teacher at S.H.E.S., who mentioned that a discussion between a parent and a police officer (Newtown Police Department) had occurred in the parking lot after she and Soto had left for the day. The discussion apparently stemmed from a parent not being at the designated school bus stop to retrieve their child off the bus. 04 didn't have any other details regarding the incident because she did not witness the incident and only heard it "second-hand" from Vicki Soto. 04 generated that another teacher, 04 generated, may have more information pertaining to the incident, as she is the one who reportedly told Vicki Soto.

04 further related that the reason for her absence today (12/14/2012) was due to a 03 that had been previously approved by her Principal, Dawn Hochsprung, over a week ago.

NOTE: At the conclusion of this interview, **04 was provided the option of writing out her own statement or having this Detective reduce it to written form. **04** work of the latter and dictated her statement, which was then transcribed by this Detective. Upon completion, **04** carefully reviewed the document for accuracy / content and indicated the entire statement was true to the best of her knowledge. This Detective then administered the oath to **04** and she subsequently signed the one (1) page statement.
