04 Detective Compagnone and I met with 04 at her residence in 03, 04 provided a verbal and written statement.

Upon talking with 04, she stated she has been employed by the school in Sandy Hook for the past 04 years.

She relayed that she is sick and was not at school that day because she was ill. 04 stated that she did not know anything about what happened at the school until she received a phone call about 10:00 am from the former assistant principal of the school who called to ask if she knew anything about Sandy Hook School being in lock down. 04

04 stated after she got the call from 04 called the school superintendents main office in an attempt to find out what was happening at Sandy Hook School. 04 stated she was informed that there had been a shooting at the school. 04 stated she turned the news on the television and that's where she got most of her information from concerning the incident. 04 stated she began getting several phone calls about what happened and got a phone call from 04, who stated she spoke with 04, both of which work at the school. 04 stated that she heard from 04 that a male came into the school during a planning and placement meeting and began shooting.

04 stated she does not have any specific information about anything firsthand, only what she was told on the phone and through the news sources. She heard from the news and phone calls that several teachers had been shot, but does not know which ones. 04 drew a diagram of the school and which teachers taught in which rooms. 04 stated she does not know the name Lanza and said no one by that name is associated with the school.
