

They had thought something had fell because she had just seen the janitor, Rick Thorn, walk by the classroom door. 04 came back into the classroom and told them they had to leave because 04 said that he thought he smelled gun powder. They began to hide but broke a classroom window and crawled out. She went on to explain that they were able to make it out of the window except for unable to get out the window so she stayed behind. They then ran off school property to, "Subway", (sandwich shop), which was across the street from the school, until they the police arrived. END OF STATEMENT.
