**INTERVIEW REPORT**

Date and Time of Investigation:

Friday, December 14th, 2012 at approximately 1150 hours.

**Summary of Incident:**

On the above mentioned date and time members of the Statewide Narcotics Task Force Northwest Office responded to the scene of Sandy Hook Elementary School located at 12 Dickinson Drive in Newtown Connecticut for a report of an active shooter within the school.

This writer interviewed several witnesses in which written statements were taken.

**ACTION TAKEN:**

On Friday December 14th, 2012 between 1150 and 1205 hours, this writer assisted [redacted] 04 with a written statement she had provided [redacted] 04 is a teacher at the school and a summary of her statement is as follows:

[redacted] 04 explained that herself and (4) four other teachers [redacted] 04 were in a meeting in classroom (20) twenty

between 9:00 a.m. and 9:30 a.m. when they heard banging noises. 04 walked out into the hallway to see what was going on. They had thought something had fell because she had just seen the janitor, Rick Thorn, walk by the classroom door. 04 came back into the classroom and told them they had to leave because 04 said that he thought he smelled gun powder. They began to hide but broke a classroom window and crawled out. She went on to explain that they were able to make it out of the window except for 04 was unable to get out the window so she stayed behind. They then ran off school property to, "Subway", (sandwich shop), which was across the street from the school, until they the police arrived. END OF STATEMENT.
