On 12/14/2012 at 0941 hrs. State Police personnel were assigned to respond to the Sandy Hook Elementary School for a reported active shooter situation. Upon arrival State Police personnel discovered multiple persons deceased, including twenty (20) children, six (6) school personnel, and

Action Taken:

On 12/18/2012 this investigator and Deputy U.S. Marshal Michael Moore were assigned to conduct an interview of [redacted] 04, 03 at Sandy Hook Elementary School, regarding this incident. This interview took place at the Town of Newtown Emergency Operations Center located at the Fairfield Hills Campus, Newtown, CT. Also present during this interview was [redacted] 04

Statement of [redacted] 03, 04

I am giving this statement to Trooper McDonald and US Marshal Moore. On 12/14/12 at around 9:35 or 9:40 AM I was driving to work from my home. I work [redacted] 04 at Sandy Hook School, [redacted] 04. As I was driving on Churchill St I saw a large number of police cruisers fly past me. I pulled over to let them go by, and then continued on towards the school. As I was pulling up towards Dickinson Drive, I saw a group of children running by the firehouse. I also saw a lot of cars pulling over because of the running. When I pulled up towards the school I parked in the first spot in the lower lot. When I parked I called [redacted] 04, and told him what was happening. I saw a lot of police cars and cops with guns. There were also ambulance people there. I never heard any gunshots or anything when I was there, and I never got close to the school. [redacted] 04 came up from our house, and we waited to see if we could do anything [redacted] 04. When I saw him I grabbed him and [redacted] 04 and I took him away from the building. We saw him come from the left side of the building. We didn't really see more than that. Eventually we ended up at the firehouse. A neighbor gave us a ride home around 1130 PM.###END### (See written statement)
