Date and Time of Investigation:

Friday, December 14th, 2012 at approximately 1250 hours.

Summary of Incident:

On the above mentioned date and time members of the Statewide Narcotics Task Force Northwest Office responded to the scene of Sandy Hook Elementary School located at 12 Dickinson Drive in Newtown Connecticut for a report of an active shooter within the school. This writer interviewed several witnesses in which written statements were taken.

ACTION TAKEN:

On Friday December 14th, 2012 between 1300 and 1318 hours, this writer assisted [04] with a written statement she had provided. [04] is a teacher at the school and a summary of her statement is as follows:

[04], a teacher in classroom [04], explained that she heard many random gunshots but thought it was from someone banging. She realized it was an emergency so she locked the doors and pulled down the shades. She moved the children behind bookshelves and she had them crouch down. She attempted to keep the children calm by reading them Christmas stories. [04] stated that she heard a male voice who she recognized to be the school janitor, Rick Thorn, trying to get the shooter to leave the building. They were later escorted by the police into an adjoining classroom ([04] classroom) and out of the school.
