Date and Time of Investigation:

Friday, December 14th, 2012 at approximately 1220 hours.

Summary of Incident:

On the above mentioned date and time members of the Statewide Narcotics Task Force Northwest Office responded to the scene of Sandy Hook Elementary School located at 12 Dickinson Drive in Newtown Connecticut for a report of an active shooter within the school. This writer interviewed several witnesses in which written statements were taken.

ACTION TAKEN:

On Friday December 14th, 2012 between 1220 and 1235 hours, this writer assisted **04** with a written statement she had provided. **04** is a teacher at the school and a summary of her statement is as follows:

04 explained that she is a **04** teacher in classroom **04** and at approximately 9:30 a.m. she heard what she thought were gunshots coming from outside her classroom in the hallway. The shots continued for what she said was a long time. She heard shouting and closed her classroom door. **04** stated that she moved the children to a coat area of the classroom and told them to be quiet. She said she continued to hear bangs. A while later the police came into her classroom and told them to stay. The police came back later and escorted them out of the school. She also explained that as she **04** she observed two legs and a gun on the floor in a classroom **04**.


