**Date and Time of Investigation:**

Friday, December 14th, 2012 at approximately 1220 hours.

**Summary of Incident:**

On the above mentioned date and time members of the Statewide Narcotics Task Force Northwest Office responded to the scene of Sandy Hook Elementary School located at 12 Dickinson Drive in Newtown Connecticut for a report of an active shooter within the school. This writer interviewed several witnesses in which written statements were taken.

**ACTION TAKEN:**

On Friday December 14th, 2012 between 1220 and 1235 hours, this writer assisted [REDACTED] 04 with a written statement she had provided. [REDACTED] 04 is a teacher at the school and a summary of her statement is as follows:

[REDACTED] 04, who is a teacher in a classroom towards the rear of the school, explained that someone came into her classroom and yelled that they were in "Lockdown". She stated that she attempted to lock her classroom door with her keys but she couldn't. At this time she said she could hear whispers coming from the loudspeaker but she couldn't make out what they were saying. She then moved the children into an adjacent classroom. After some time she heard the police yelling at them to come out and that they were safe. They were then escorted out of the school.

**Case Under Investigation**
