

she was reunited with her son, and learned he had been picked up on the road by a woman who recognized one of the children running with 01 02 03 12

In addition to the information contained in the statement, 404 also provided the following information verbally: 404 stated the caller did not seem to be malicious in anyway, he was excited and trying to provide the information as fast as possible.

A follow up with the phone number of 03, 04 later determined that the number belonged to 04, 03 a resident of Sandy Hook who was near the School at the time of the shooting and stopped to help. The phone number was his cell phone number which he had purchased when he lived in New Jersey. See report and written statement for 04 for additional details.
