ACTION TAKEN: Interview of 04, 03) on 12/14/12 at 2131 hours

On the above mentioned date and time this Detective and Det. Kimball interviewed 04 at her residence.

04 was interviewed because she had received a strange call on her home phone on the morning of the shooting. The name on the caller identification listed 04. This was a concern because early in the investigation there appeared to be some tie with New Jersey, and this was a New Jersey telephone number.

At approximately 2131 hours on 12/14/12 04 began her statement. 04 completed her written statement at 2140 hours on 12/14/12. 04 swore to and signed her statement. (See attached written statement) Among other things, 04 provided the following information in her statement:

04 stated she received a call on her home phone at 9:44AM from an unknown male caller. The name on the caller identification listed 04. The caller stated she should get to Sandy Hook School right away, if she had 04; and it was bad and kids were running up the street. He stated a child had given him this phone number. The caller mentioned something about it being "bloody". 04 stated she heard children yelling in the background. 04 stated 01 02 03 12 went to school at the Sandy Hook Elementary School. 04 went to Newtown Police Department where

she was reunited with her son, and learned he had been picked up on the road by a woman who recognized one of the children running with 01 02 03 12

In addition to the information contained in the statement, 04 also provided the following information verbally: 04 stated the caller did not seem to be malicious in anyway, he was excited and trying to provide the information as fast as possible.

A follow up with the phone number of 03, 04 later determined that the number belonged to 04, 03 a resident of Sandy Hook who was near the School at the time of the shooting and stopped to help. The phone number was his cell phone number which he had purchased when he lived in New Jersey. See report and written statement for 04 for additional details.
