Date and Time of Investigation:

Friday, December 14th, 2012 at approximately 1300 hours.

Summary of Incident:

On the above mentioned date and time members of the Statewide Narcotics Task Force Northwest Office responded to the scene of the Sandy Hook Elementary School located at 12 Dickinson Drive in Newtown Connecticut for a report of an active shooter within the school. This writer interviewed several witnesses in which written statements were taken.

ACTION TAKEN:

On Friday December 14th, 2012 at approximately between 1300 and 1320 hours, this writer assisted [04] with a written statement she had provided. [04] is a teacher at the school and a summary of her statement is as follows:

[04] explained that she teaches out of classroom [04] and at approximately 9:30 a.m. she heard gunshots coming down the hallway from outside her classroom. She said that the gunshots were loud and seemed close. She gathered the children in the front of the classroom. She stated that the loudspeaker came on and she heard crying in the background [04] went on to explain that she called 911 emergency and went to lock her classroom door. Once the gunshots paused she could smell gun powder coming from the hallway. She looked and did not see anyone. She attempted to cover the door window and calm the children down. At this time she stated that she heard more gunshots. The gun shots stopped and she could hear crying and voices over the loudspeaker. She continued to keep the children calm until the police arrived and escorted them out of the school.
