As I walked toward the door I stepped on what I thought was rock salt on the sidewalk, then I saw the broken glass window next to the entrance doors. I saw a bullet hole in the glass, and then I realized there was a something bad going on and I needed to get away from the front of the school. As I was turning away from the school, I noticed another woman walking toward the school. At this time I heard sirens in the distance. We both heard what I now know was gunfire, and we ran to the right side of the dumpsters to hide. Police officers arrived and we identified ourselves to them. I called my husband on my cell phone to tell him what was going on. I called my husband at 9:42 am on my cell phone. One Newtown Police officer and one State Police Officer came over to protect us. I was behind the dumpster for about an hour because the last call made on my phone before I left from behind the dumpsters was made at 10:21 am. This is all I can remember right now." END OF STATEMENT.

In addition to the information contained in the statement, **1000** 04 also provided the following information verbally:

04 stated that she arrived at the school early for her 0945 appointment. **04** said she knows this because her call to her husband at 9:42AM was placed when she was behind the dumpsters after running from the front of the school. **04** also added that the front door to the school was locked. **04** said that the banging noises she initially heard stopped, and then started again. **04** was not able to recall how many gunshots she heard.
