the door of the meeting room and could smell what was known to him to be gunpowder. 04 said that he and a few of his other colleagues began to run. 04 said that he exited the meeting room into the hallway, turned right (facing south/southwest), and ran down the hallway (south/southwest), away from the sound of the gunshots. 04 continued to run down the hallway to an exit door on the right side (west side) toward the rear of the school and exited through that door. Once outside, 04 ran in a northwesterly direction, up and over a small embankment. 04 continued to run in a northwesterly direction until reaching the Villa Restaurant And Pizza, 4 Riverside Road, Sandy Hook, CT (an approximate distance of 215 yards). 04 stated that he entered the restaurant and used a phone to call 9-1-1 and reported the incident to police.

said he believed that possibly two of the female teachers who were initially with him in the meeting room, had remained inside that room after he had left. 04 said that after the incident he had met up with one of the female teachers who had remained in the room who told 04 that she and another female teacher had broken out a glass window in the room, crawled out through the window, and ran from the school to escape.


