

of the gunshots and muffled voices being broadcast over the schools intercom/loud speaker. That soon after she could see armed police officers outside of the classroom on the playground area but kept hearing what appeared to her to be additional gunshots coming from inside the school.

O4 said that soon after there was banging on their classroom door and voices who identified themselves as the state police.

O4 stated that she, the nineteen children, and the two other teachers followed the police out of the classroom, through the hallway of the school, and out a rear exit. The entire class was then led down the street to the Sandy Hook Fire Department.
