Interview and Witness Statement of **04**

ACTION TAKEN: On Friday, December 14, 2012, at approximately 1311 hours, I interviewed **04, 03**, at the Sandy Hook Fire Department regarding her observations involving a shooting incident which had taken place at approximately 0930 hours at the Sandy Hook Elementary School, 21 Dickinson Drive, Newtown, CT. **04** is a **04** and was present inside the school when the incident began. **04** later provided a two-page handwritten witness statement, written in her own words, as well as a hand drawn sketch map (on page 2 of statement) of her approximate location in the school when the incident began.

04 provided the following information:

04 stated that she is a **04** at the Sandy Hook Elementary School. On the morning of Friday, December 14, 2012, she was inside **04** along with **04**, and assistant teacher **04**. The classroom is located in what is considered to be the "new section" of the school, on the southeast side near the outdoor playground, to the far rear of the building, opposite the main entrance. **04** said that there were a total of nineteen (19) children and three (3) adults present in room **04**. That at approximately 9:30AM, she heard banging noises that she believed were gunshots coming from somewhere in the hallway of the school. **04** told **04** that she thought their classroom should go into lockdown mode. **04**, **04** and **04** locked the classroom door, closed the blinds on the windows, and took the nineteen children to the "cubbie" area of the classroom. **04** said she then began to hear the sound

of the gunshots and muffled voices being broadcast over the schools intercom/loud speaker. That soon after she could see armed police officers outside of the classroom on the playground area but kept hearing what appeared to her to be additional gunshots coming from inside the school. [REDACTED] 04 said that soon after there was banging on their classroom door and voices who identified themselves as the state police. [REDACTED] 04 stated that she, the nineteen children, and the two other teachers followed the police out of the classroom, through the hallway of the school, and out a rear exit. The entire class was then led down the street to the Sandy Hook Fire Department.
