



INTERVIEW REPORT											



ACTION TAKEN:

On December 15th, 2012 at approximately 1235hrs, Detective Marc Grandpre and I spoke with and obtained a written statement from Ms. Kaitlin M. Roig. Roig was identified during this investigation as a first grade teacher at Sandy Hook Elementary School. Ms. Roig teaches in classroom 12 and was working at the school when the shooting took place on Friday, December 14th, 2012. As such, I was assigned to speak with Roig as part of this investigation.

Roig agreed to meet with these Detectives at her residence in

At this time I asked Roig to hand write, in narrative form, her account of what had transpired at the school on Friday morning, December 14th, 2012. Roig related that at approximately 0935hrs, she was with her students in classroom 12. At that time she heard what she described as "rapid fire shooting" outside of the school, right outside of her classroom.

Following the school's lock down protocol, Roig immediately closed her classroom door, shut the lights off and moved all of her students into the

classroom's bathroom. She pulled a rolling storage unit in front of the bathroom door as a barricade and then closed and locked the bathroom door.

Roig related that while in the bathroom, she heard the sound of rapid fire shooting which appeared to be coming from the hallway area outside of her classroom. The shooting sounds continued for what Roig guessed to be a 10 minute time period. During that time she heard voices of unknown persons stating "oh please no, please no". Roig then heard voices of what sounded to her to possibly be that of police officers. She didn't know for certain whether it was the police or the perpetrator/s of the school shooting and as such decided to remain in the bathroom with her students. Sometime thereafter, police officers identified themselves to Roig by sliding their badges under that bathroom door. However, Roig demanded that if they were in fact the police they should be able to obtain a key for the bathroom door. Said police officers obtained a key, unlocked the bathroom door and led Roig and her students out of the school. (See Attached Statement For Further Details)

On Friday, December 21st, 2012, I again spoke with Roig via telephone in an effort to expound on information that she provided in her original statement. I thereafter completed a formal typed statement based on the information that she provided.

In summary, Roig related that the construction paper covering the window on her classroom door had been left in place from a prior practice lock down drill. That she originally believed that her personal cellular telephone was taken from her room, presumably by someone entering her room and then leaving her classroom door open. However, in hindsight, Roig was not certain that she had actually seen her classroom door open after closing it. That in not being able to locate her phone, she may have assumed that it was open, associating that with someone entering her classroom and taking her phone. Roig recalled that the interior classroom door, which leads to the adjoining classroom, was closed and not locked. With regard to the sound of gunfire, she did not recall any specific breaks or pauses and described it to be more alike an ongoing event.

After completing the above typed statement, I contacted Roig via telephone. I read the statement to Roig who confirmed that it was a true and accurate representation of our previous discussion. Roig agreed to physically review and officially sign the statement. I forwarded said statement to Major Crime Sergeant, Sgt. Mark Davison, who thereafter assigned Detectives Thomas Kiley and Peter Pinelli to present and witness the signing of the statement by Roig. (See Attached Statement For Further Details)

CASE STATUS: This case remains active pending further investigation.
