

provide a brief narrative statement. In summary, she related that at approximately 0930hrs, she was in a PPT meeting with the Principal and several others. At approximately 0935hrs, she heard what she described as a "few pops". The Principal ran out of the room, along with the school psychologist, to investigate the source of these sounds. One of the teachers in the meeting, "Natalie", ran and shut the meeting room door and thereafter said that she had been shot. O4 related that Natalie had said that "he had a mask on". O4 a parent attending the meeting, called the police via telephone. O4 related that she heard kids screaming and the sound of shots being fired followed by silence. Sometime thereafter, O4 was evacuated from the school by responding police officers. (See Attached Statement)

CASE STATUS:

This case remains active pending further investigation.
