ACTION TAKEN:

On the morning of Friday, December 14th, 2012, I responded to an active shooter incident at the Sandy Hook Elementary School in Sandy Hook CT. Shortly after arriving, I was assigned to speak with and obtain a statement from 04, 03 04 is 04 working at several schools within the Newtown Public School system. She was present during the shooting incident at Sandy Hook Elementary School. I located and spoke with 04 at the Sandy Hook Volunteer Fire and Rescue Station, located at 18-20 Riverside Rd Sandy Hook, CT. The Fire and Rescue Station was designated and being utilized as a staging area for first responders as well as a gathering and meeting point for school staff, students and their respective families.

I provided 04 with a piece of formal statement paper and asked if she could write, in narrative format, her recollection of the events that she was part of or witness to during the shooting incident at the Sandy Hook Elementary School. 04 appeared visibly shaken and upset, but agreed to

provide a brief narrative statement. In summary, she related that at approximately 0930hrs, she was in a PPT meeting with the Principal and several others. At approximately 0935hrs, she heard what she described as a "few pops". The Principal ran out of the room, along with the school psychologist, to investigate the source of these sounds. One of the teachers in the meeting, "Natalie", ran and shut the meeting room door and thereafter said that she had been shot. 04 related that Natalie had said that "he had a mask on". 04 a parent attending the meeting, called the police via telephone. 04 related that she heard kids screaming and the sound of shots being fired followed by silence. Sometime thereafter, 04 was evacuated from the school by responding police officers. (See Attached Statement)

CASE STATUS:

This case remains active pending further investigation.
