**INTERVIEW REPORT**

**ACTION TAKEN:**

On the morning of Friday, December 14th, 2012, I responded to an active shooter incident at the Sandy Hook Elementary School in Sandy Hook CT. Shortly after arriving, I was assigned to speak with and obtain a statement from [REDACTED] 04, 03 is an Educational Assistant who was working at Sandy Hook Elementary School when the shooting incident occurred. I located and spoke with [REDACTED] 04 at the Sandy Hook Volunteer Fire and Rescue Station, located at 18-20 Riverside Rd., Sandy Hook, CT. The Fire and Rescue Station was designated and being utilized as a staging area for first responders as well as a gathering and meeting point for school staff, students and their respective families.

I provided [REDACTED] 04 with a piece of formal statement paper and asked if she could write, in narrative format, her recollection of the events that she was part of or witness to during the shooting incident at the Sandy Hook Elementary School. In said statement, [REDACTED] 04 related that she arrived at the school at approximately 0930hrs and thereafter proceeded to her classroom, room [REDACTED] 04. Approximately 5 minutes later, she heard what

sounded to her to be continuous "popping" sounds. The school custodian, "Rick", directed [04] to close her door. [04] related that Rick had his phone in his hand and that the popping sounds seemed to stop briefly and then began again. [04] directed her students to the back of the class room and [04] locked the classroom door and covered the window.

At approximately 1000hrs, [04] heard voices out in the hallway stating, "put your hands up, police." About 10-15 minutes thereafter, she and her students were evacuated from the school by responding police officers on scene. (See Attached Statement)

CASE STATUS: This case remains active pending further investigation.
