ACTION TAKEN:

On the morning of Friday, December 14th, 2012, I responded to an active shooter incident at the Sandy Hook Elementary School in Sandy Hook CT. Shortly after arriving, I was assigned to speak with and obtain a statement from [REDACTED] 04, 03 [REDACTED] is an [REDACTED] 04 [REDACTED] teacher who was working at Sandy Hook Elementary School when the shooting incident occurred. I located and spoke with [REDACTED] 04 [REDACTED] at the Sandy Hook Volunteer Fire and Rescue Station, located at 18-20 Riverside Rd., Sandy Hook, CT. The Fire and Rescue Station was designated and being utilized as a staging area for first responders as well as a gathering and meeting point for school staff, students and their respective families.

I provided [REDACTED] 04 [REDACTED] with a piece of formal statement paper and asked if she could write, in narrative format, her recollection of the events that she was part of or witness to during the shooting incident at the Sandy Hook Elementary School. In said statement, [REDACTED] 04 [REDACTED] related that at approximately 0930hrs, she was in a PPT meeting in room 9 with the school Principal, several other school staff and a parent of a school student. minutes into the meeting, she heard "3 loud pops (shots)". Three individuals, who she identified as Dawn Hochspring, Mary Sherlock and Natalie Hammond, ran out of the room. She then heard several more "shots fired". She and the others in the room hid under tables and Hammond ran back into the room and closed the door. At that time Hammond stated, "I've been shot". Hammond laid on the floor and held the door closed. The parent in the room, who she identified as [REDACTED] 04, called 911 using her cellular telephone. 04 related that she heard shots being fired for what appeared to her to be approximately 10 minutes.

While [REDACTED] 04 was on the telephone, Hammond provided her with a description of what she had seen. Hammond related that she saw a person with a mask and that Hochspring and Sherlock had been shot. 04 related that she heard shots being fired right outside in the front hallway. It sounded to her like the shooter was walking up and down the front hall shooting. At one point she heard kids screaming. 04 stayed in the room until two police officers came to the door and helped Hammond and escorted the rest of them out of the school.
