ACTION TAKEN:

On the morning of Friday, December 14th, 2012, I responded to an active shooter incident at the Sandy Hook Elementary School in Sandy Hook CT. During the course of the subsequent investigation into this incident, I was assigned to speak with and obtain a statement from 04 [Redacted] was identified as a parent of a student who attended Sandy Hook Elementary School. She was attending a meeting at Sandy Hook Elementary School when the shooting incident occurred.

I located and spoke with 04 [Redacted] at her 03 [Redacted] residence. 04 [Redacted] resided in a 04 [Redacted] residence along with 04 [Redacted]. I provided 04 [Redacted] with a piece of formal statement paper and asked if she could write, in narrative format, her recollection of the events that she was part of or witness to during the shooting incident at the Sandy Hook Elementary School. In said statement, 04 [Redacted] related that at approximately 0930hrs, she arrived at the school for a PPT meeting with the school Principal and other school staff members. Shortly after the

meeting commenced, she heard "shots". Three school staff members left the meeting to investigate the source of the shooting sounds. One of the staff members, who 04 identified as Natalie Hammond, returned to the conference room and stated that she had been shot. That Hammond told her that the shooter had been wearing a mask. At this time 04 was on her cellular telephone with the "911" dispatcher. She related that she heard numerous shots being fired in the hallway outside of the conference room. 04 then heard shouting and shortly thereafter police officers entered the room she was in, stabilized Hammond and later evacuated them from the school.
