Date and Time of Investigation:

December 14th, 2012 at approximately 1220 hours

Summary of Incident:

On the above mentioned date and time members of the Statewide Narcotics Task Force Northwest Office responded to the scene of Sandy Hook Elementary School located at 12 Dickinson Drive in Newtown Connecticut on a report of an active shooter within the school. This writer interviewed several witnesses that were inside the school when the shooting occurred, witnesses were asked to give written statements about the incident that occurred.

On December 14, 2012 at approximately 1220 hours, this writer interviewed [REDACTED] 04, 03 [REDACTED], at the Sandy Hook Fire Department regarding her observations involving a shooting incident which had taken place at approximately 0930 hours at Sandy Hook Elementary School, 12 Dickinson Drive, Newtown, CT. 04 a teacher was present inside the school when the incident began. 04 provided her own one-page handwritten witness statement. 04 provided the following information:

04 stated that on December 14, 2012 at approximately 9:30 she heard shots fired, coming from the direction of the lobby. 04 stated that she closed the door and took 01 02 into the bathroom and closed the door. 04 stated they sat on the floor and stayed as quiet as possible. 04 stated they listened to gunshots for what felt like an eternity. 04 stated that the gunman walked past our room, firing all the time. 04 stated they could tell he had stopped a few times and fired a lot. 04 stated they huddled together, praying for it to end. The shots lasted for 10-15 minutes. 04 stated she checked her watch at 10:50, after the shots had been stopped for a while. 04 stated they remained in the bathroom until someone came in and said "No one's here". They heard things from the loudspeaker through the entire process. 04 stated she heard female voices, sounded like they were crying, but it wasn't very clear. 04 states once they came out of the bathroom and saw police, they came out and exited the building. (see attached original statement)

On January 16, 2013 at approximately 1500 hrs this writer contacted 04 via cell phone # 04, 03 to confirm her location inside Sandy Hook Elementary School on the morning of December 14, 2012. 04 stated that both her and student 01 02 were inside the bathroom of room 04
