Date and Time of Investigation:

December 14th, 2012 at approximately 1245 hours

Summary of Incident:

On the above mentioned date and time members of the Statewide Narcotics Task Force Northwest Office responded to the scene of Sandy Hook Elementary School located at 12 Dickinson Drive in Newtown Connecticut on a report of an active shooter within the school. This writer interviewed several witnesses that were inside the school when the shooting occurred, witnesses were asked to give written statements about the incident that occurred.

ACTION TAKEN:

**03 04**, at the Sandy Hook Fire Department regarding her observations involving a shooting incident which had taken place at approximately 0930 hours at Sandy Hook Elementary School, 12 Dickinson Drive, Newtown, CT. **04** a teacher was present inside the school when the incident began. **04** provided her own one-page handwritten witness statement as well as a hand drawn sketch map of her location in the school when the incident began. **04** provided the following information:

**04** stated that she was in the Gymnasium with **04** classes along with **04** on December 14, 2012. **04** stated around 9:35 she was giving directions when they heard gunshots. **04** stated approximately one round was fired then the gunshots stopped for a few seconds. **04** stated that they moved the kids and headed to the back part of the gym, and had the children crawl into the closet. **04** stated that they heard banging for the Police to open the doors and evacuated the gym at that point. **04** stated all students were accounted for as we left the gym. (see attached original statement)
