On December 14, 2012 at approximately 1200 hours, this writer interviewed [REDACTED] 04, 03 [REDACTED], at the Sandy Hook Fire Department regarding her observations involving a shooting incident which had taken place at approximately 0930 hours at Sandy Hook Elementary School, 12 Dickinson Drive, Newtown, CT. 04 was a [REDACTED] 04 [REDACTED] and was present inside the school when the incident began. 04 provided her own one-page handwritten witness statement. 04 provided the following information:

04 stated that at 9:30 she heard many gunshots fired in the front of the building, she was with another adult 04, who closed the classroom door. 04 and the students in the classroom then hid inside the coat closet. 04 then stated that the intercom picked up, and was left on but no voices were heard all that was coming over the intercom was gun shots which 04 said lasted for 20-30 minutes. 04 stated that she heard men yelling and talking the whole time over the intercom. 04 further stated that at some point a Police Officer came to the door and asked them how many people were inside the classroom and told them to stay down. 04 stated 10 minutes later Two Police Officers yelled for them to leave the school, 04 and the students held hands and ran out the front door to the Fire Station no students were injured.
