

The intercom is also activated over the phone and can be used in two different ways. The first way is to press the star key (\*), the zero (0) and the classroom number. This rings the respective phone in the classroom and you would talk from phone to phone when you followed this procedure.

The second way to use the intercom is by pressing zero (0) and the classroom number which would allow me to make an announcement over the classroom speaker for just that room.

On 12/14/12 just after I heard the noise and saw the shooter in the building, I received a call at my desk from the Library. When I answered the phone someone said " 04 what is going on?" I yelled into the phone, "Lockdown, we have a shooter in the building!" I then dropped the phone handset on the floor and hid. I am not sure if the phone line remained open, I was just trying to take cover. This is a technical question that I can't answer. I later learned that the person who called from the Library that morning was 04.

On that morning (12/14/12) neither I nor 04 activated the public address system or intercom from our office.

I want to add, we have two phone systems. One phone is used for the public address and intercom, the second phone is an outside phone line to call out of the school." END OF STATEMENT
