the shooting, she was walking in the hallway on the southern (back) side of the school and rounded the corner proceeding toward the front of the school in the west hallway. As she rounded the corner and proceeded onto the west hallway, she came upor 04 instructed her to get inside a classroom and then overheard 04 talking on his cellular telephone about the possibility of a shooter being in the building. 04 banged on the door of class room 04. The teacher in said room had already locked the door, but unlocked it an allowed to enter. As she crouched in down in the room, she heard "many, many shots ringing" through the school's intercom system. The shots began to sound more and more distant.

had a partially obstructed view from inside room , across the courtyard, to the hallway on the eastern side of the building. At approximately 0945hrs, she noticed what appeared to her to be 3 or 4 people in dark clothing walking down the east hallway near the computer lab, room 49. She saw one of these persons carrying what appeared to be a long gun. Over the intercom, she could hear people sobbing in the main office. She also heard sirens and the voices, of what she thought were police officers, coming over the intercom system. 404 The related that the police apprehended someone just outside of room . She heard, "Drop your weapon, put your hands up!!". Sometime thereafter, the police evacuated she and the others from room . They were directed to leave via the rear of the school following which they proceeded to the Sandy Hook Volunteer Fire and Rescue Station.
