Date and Time of Investigation:

December 14th, 2012 at approximately 1250 hours

Summary of Incident:

On the above mentioned date and time members of the Statewide Narcotics Task Force Northwest Office responded to the scene of Sandy Hook Elementary School located at 12 Dickinson Drive in Newtown Connecticut on a report of an active shooter within the school. This writer interviewed several witnesses that were inside the school when the shooting occurred, witnesses were asked to give written statements about the incident that occurred.

ACTION TAKEN:

On December 14, 2012 at approximately 1250 hours, this writer interviewed [REDACTED] 04, 03 [REDACTED], at the Sandy Hook Fire Department regarding her observations involving a shooting incident which had taken place at approximately 0930 hours at Sandy Hook Elementary School, 12 Dickinson Drive, Newtown, CT. 04 [REDACTED] a teacher was present inside the school when the incident began. 04 [REDACTED] provided her own one-page handwritten witness statement. 04 [REDACTED] provided the following information:

04 [REDACTED] stated that on December 14, 2012 at approximately 9:35 am they heard what sounded like fireworks and at first she thought maybe the furnace was having issues. 04 [REDACTED] then said she heard another round of noise, her co-worker 04 [REDACTED] gathered the students to the corner, while she went to the gym doors. 04 [REDACTED] stated that she used pre-cut circles to cover the windows and then locked the doors. One door was not locking and Rick (Custodian) was out in the hallway she motioned to him to lock the door. 04 [REDACTED] quickly got additional paper to cover the two side doors. 04 [REDACTED] then went to the door near the music room side and she saw shadows of maybe two people run by. They continued to hear voices and we continued to keep the students calm. 04 [REDACTED] stated Police came in using keys and checked in with them, and they were able to hear voices over the loud speaker and this was upsetting the students. 04 [REDACTED] stated that she and her co-teacher 04 [REDACTED] decided to move the students to the equipment closet/office. They stayed there until they heard noises at the outer gym doors. 04 [REDACTED] then went out to check and the Police were having students leave the school, so they removed the students from the closet and proceeded to the Firehouse. 04 [REDACTED] was inside the gym when the shooting took place. (see attached original statement)
