Action Taken: On 1/6/13, this Detective received an e-mail message from 01 02 03 12 regarding, in part, additional information relayed to her by her son, <sup>01 02 03 12</sup> who was a student in 01 02 05 12 classroom (see attached.)

01 02 03 12 stated that her son, 01 02 03 12 told her a longer and more detailed version of what he had told her earlier. 01 02 03 12 stated that 102 03 12 told her that 01 02 03 12 told her a longer and more detailed version of what he had told her earlier. 01 02 03 12 stated that 102 03 12 told her that 01 02 03 12 told the children to line up against the wall in the classroom because they heard a small amount of gunshots and that the teacher (unspecified in the e-mail if it was 01 02 03 12 was looking either out the door into the hall or out the window into the hall when the shooter "busted in" and was firing the gun in the room. 102 03 12 told his mother that he saw 01 02 12 fall down, and stated that he saw the bullets or casings coming out of the gun. 102 03 12 stated that he was ducking behind a desk in the classroom and that the gunman had come in through the hallway door to the classroom. 102 03 12 stated that he and the other children ran while he was reloading, and that the children running in front of him were<sup>01 02 03 12</sup> additionally stated that <sup>01 02 03 12</sup> was in the group of children running as well, but that he

did not know where. discussed that there was smoke in the hallway, and that he saw blood and bodies in the hallway as well.

The status of the case remains actively under investigation.
