DATE AND TIME OF INVESTIGATION:

Friday, December 14, 2012, at approximately 0930 hours

SUMMARY OF INCIDENT:

On the above mentioned date and time members of the Connecticut State Police, along with numerous other municipal and federal law enforcement agencies responded to an active shooter call at the Sandy Hook Elementary School, located at 12 Dickinson Drive, Newtown, Connecticut.

ACTION TAKEN:

On Friday, December 14th, 2012 between 1414 and 1500 hours, I Detective Flockhart #2053, interviewed [REDACTED] 04, 03 [REDACTED] is a 04 at the school. 04 provided this writer with the attached sworn written statement. The following is a breakdown of the statement but is not inclusive to everything 04 stated on the day of the incident:

"My name is 04. I am a 04 the Sandy Hook Elementary School, located at 12 Dickenson Drive, Sandy Hook, CT. I have worked there for approximately 04 years.

On 12/14/12 I arrived at school around 7:30 am, because 04 had called in sick. I normally come to work around 8:50 am. I came in and spoke to the principal Dawn Hochsprung about teachers or other staff members who were out ill. Then I continued with my daily opening routine, which includes: opening files, staff information sheet, and prepare the student absent sheet. Around 8:55 am buses and parents arrived to drop the children off. School started at 9:05 am. I worked with a building substitute who helped me with the phones and other office duties. The substitute 04 left the office around 9:25 am. Around 9:35 I heard a loud noise, which sounded like glass breaking. I

thought one of the glass casings in the hallway had fallen over. I was going to call the school custodian, but then I heard it again and looked up. When I looked up from my desk through the office glass window that looks out to the lobby I saw a man standing in the lobby facing down the primary wing (hallway) to the 1st grade and 2nd grade classrooms. The man appeared white and was wearing a soft rim type hat, sunglasses (dark), and he was holding a rifle type gun with a long barrel. As I saw the man I heard a loud "pop, pop" noise of the gun going off. I immediately dropped to the floor, yelled to [04] who was in the nurse's office, and hid under the desk. The door to the office opened and I heard footsteps of a person walking across the office floor. I could not see anything, I just heard footsteps, walking towards [04] office. I then heard the footsteps go back across the office and out the door. I then heard the office door shut. After the door shut I heard more firing from a gun. I called out to [04] [04] told me to come into her office. I got up from under my desk and went into [04] office and got under her desk with her. I knew we needed the police, so I pulled the phone down from [04] desk and called 911. A male answered. I told them my name and that I was from the Sandy Hook School and said I think there is someone in the building shooting or there's a shooter. I hung up and called the school system central office. I got a voicemail and just hung up. I tried another phone number for central office and got another voicemail. I then called the transportation phone number and spoke to [04] from Allstar Transportation. Told [04] my name, what school I was at, and that we needed help down here. I remember shaking and my mouth going dry. [04] and I then went into her office closet and locked the door and stayed there. I don't remember hearing any more gun shots. I heard a sound of a helicopter radio's in the hallway, people talking, but we stayed in the closet, because we were too scared to come out. I wasn't sure what time it was, but [04] heard someone talking in the office and decided to peek out. When she opened the door, I heard a man's voice ask [04] "Are you alone?" [04] replied "no, that [04] is with me." [04] and I then came out of the closet and saw so many police officers in the office.
