thought one of the glass casings in the hallway had fallen over. I was going to call the school custodian, but then I heard it again and looked up. When I looked up from my desk through the office glass window that looks out to the lobby I saw a man standing in the lobby facing down the primary wing (hallway) to the 1st grade and 2nd grade classrooms. The man appeared white and was wearing a soft rim type hat, sunglasses (dark), and he was holding a rifle type gun with a long barrel. As I saw the man I heard a loud "pop, pop" noise of the gun going off. I immediately dropped to the floor, yelled to 04 who was in the nurse's office, and hid under the desk. The door to the office opened and I heard footsteps of a person walking across the office floor. I could not see anything, I just heard footsteps, walking towards 04 office. I then heard the footsteps go back across the office and out the door. I then heard the office door shut. After the door shut I heard more firing from a gun. I called out to 04 04 told me to come into her office. I got up from under my desk and went into 04 office and got under her desk with her. I knew we needed the police, so I pulled the phone down from 04 desk and called 911. A male answered. I told them my name and that I was from the Sandy Hook School and said I think there is someone in the building shooting or there's a shooter. I hung up and called the school system central office. I got a voicemail and just hung up. I tried another phone number for central office and got another voicemail. I then called the transportation phone number and spoke to of from Allstar Transportation. Told of my name, what school I was at, and that we needed help down here. remember shaking and my mouth going dry. 04 and I then went into her office closet and locked the door and stayed there. I don't remember hearing any more gun shots. I heard a sound of a helicopter radio's in the hallway, people talking, but we stayed in the closet, because we were too scared to come out. I wasn't sure what time it was, but 04 heard someone talking in the office and decided to peek out. When she opened the door, I heard a man's voice ask 04 "Are you alone?" 04 replied "no, that 04 is with me." 04 and I then came out of the closet and saw so many police officers in the office.
