DATE AND TIME OF INVESTIGATION:

Friday, December 14, 2012, at approximately 0930 hours

SUMMARY OF INCIDENT:

On the above mentioned date and time members of the Connecticut State Police, along with numerous other municipal and federal law enforcement agencies responded to an active shooter call at the Sandy Hook Elementary School, located at 12 Dickinson Drive, Newtown, Connecticut.

ACTION TAKEN:

On Friday, December 14th, 2012 between 1215 and 1237 hours, I Detective Flockhart #2053, interviewed [REDACTED] 04, 03 [REDACTED] 04 [REDACTED] is an [REDACTED] 04 [REDACTED] at the school. [REDACTED] 04 [REDACTED] provided this writer with the attached sworn written statement. The following is a breakdown of the statement but is not inclusive to everything [REDACTED] 04 [REDACTED] stated on the day of the incident:

"I am an [REDACTED] 04 [REDACTED] in room [REDACTED] 04 [REDACTED] is located on the right side of the building (school). Around 9:35 I was in room [REDACTED] 04 [REDACTED] when I heard loud noise that sounded like "popping". I thought something fell. I thought it might be the glass case that is to the right of the front entrance of the school. I went into the hallway and realized it was (gun) shots. I saw the janitor running to the entrance of the school, at which time, I went back into the classroom. I then heard yelling, he [REDACTED] 04 [REDACTED] and it appeared he was talking to someone. I immediately went into the classroom and told the teacher to lock down. After we went into lock down the loud speaker went on and I heard [REDACTED] 04 [REDACTED] try to make an announcement, but she was crying. I then heard more rapid (gun) shots which seemed to go on for a long time. At some point there was a brief pause in the shots. Around 9:50, I called 911 from the classroom and while I was on the phone with the 911 operator, someone shook our
