On 12-14-2012, I responded to the scene of a school shooting at the Sandy Hook Elementary School in Newtown, CT. Among other responsibilities, I assisted in obtaining a written and verbal statement from **Control 104, 03** an **Control 104** Of the Sandy Hook Elementary School.

In a written and verbal statement, **1004** related, while in her classroom at approximately 9:35 a.m., with the teacher and students, she heard the intercom come on. Through the intercom she heard muffled sounds and cries. They first thought it was an accident and began to walk down the hall toward the office. As **104** turned the corner she realized other classrooms were shutting their doors, so she walked back to her classroom. The teacher next door said "Lockdown". She and the the class teacher locked and covered the door. They still heard what sounded like noises, moans and gunshots. They told the kids to be quite after the classroom teacher received a text message informing her there was a gunman. The teacher and children from the classroom next door came into there room and waited until the police knocked on the door and let them out. Refer to attached statement.
