room (room 04 and was walking northerly in the east hallway, toward the front of the school. She was walking with her student 01 02 03 12
and as they were just about to turn onto the north hallway and proceed to the school resource room (room #6), she heard the sound of
gunfire. As she then turned the corner onto the north hallway, she observed Principal Hochspring exiting the conference room in a panic, looking
around. At this time 04 paused, unsure if she should proceed toward her room or retreat back to the east hallway. As she stood there, she saw
the Principal proceed toward the main lobby following which 04 heard additional gunfire.

Although in her original written account of events, 04 thought she had seen a man in the lobby area, she later related verbally that she didn't think she actually saw anyone. She clarified that after the Principal proceeded toward the main lobby, 104 grabbed her student and then turned room, fleeing southerly down the east hallway. While running in the east hallway, she saw a man standing in the and ran back toward 04 hallway who asked her. "What?" 04 replied, stating that she did not know. During this whole time, she continued hearing the sound of gunfire. 04 proceeded into the art room (room #51) and advised the teacher in the class that she thought there was a shooter in the school. She then sought refuge in the art room with her student until the police arrived and evacuated them.

of the related that the male she saw in the east hallway was wearing dark clothes and a waist length coat. He was a white male and had his hands in his pocket. Sometime after the incident, 04 was informed that the male she saw in the east hallway was a student's parent in the school who was waiting to meet with a kindergarten teacher. She related that he was near the entrance which is used by pre-school parents to enter the school to drop off their children. (See Attached Statement)
