**ACTION TAKEN:**

On 01/11/13 at approximately 1500 hours, I was assigned to contact 04 to follow up on her original statement taken on 12/17/12. At approximately 1505 hours, I contacted 04 via phone at her residence. I asked 04 how she determined that all the doors were locked. 04 indicated that upon approaching the doors, she tried all three of the front doors and realized that all three doors were locked. 04 stated that she expected them to be locked since the doors are always locked at that time of the day. I asked 04 when she called her husband from behind the dumpsters, did she talk to him directly or leave him a voicemail. I asked this to determine if there would be a recording of the gunshots that she was hearing. 04 indicated that she spoke to him directly and told him to go to the firehouse to look for 01 02 03 12. 04 stated that there would not be a recording anyway because she didn't call him until the shooting had stopped and the police were on scene. asked 04 what make/model car she was driving. 04 stated that she was driving a 04 I also confirmed that when she saw the children running away from the school, they were near the stop sign where Dickinson Dr. enters into the school parking lot. This was to establish an estimated time of her arrival in relation to the time of the shooting. By the time she arrived, the children had already exited the school and crossed the parking lot to Dickinson Dr. She parked in the third row and walked to the front doors and shots were still being fired.

CASE STATUS:
