

provided the attached written statement. The statement reads as follows: within the school at the time of the shooting. 04

I was standing at the computer in the kitchen about 9:30 a.m. on 12/14/12. I heard popping sounds. About 7-10. Then 7-10 more. Loud like they were coming from the front lobby. I dropped to the ground behind the servery and crawled to the closet. 04 was behind the table behind me. She also dropped to the ground and crawled to the closet. One inside we closed the door. 04 crouched on the floor and I was standing. Shots continued 7-10 at a time - then a pause - then 7-10 more. At first they were loud. Then they were farther away. Then appeared to be loud again like they were being fired close to the kitchen. From the closet, I called 911 and received no answer. Tried again maybe three minutes later and spoke to an operator and told her shots fired at the Sandy Hook School. Still hearing a few shots fired. Kids were screaming. After what seemed to be 25 minutes we began to hear police on the premises. We remained in the closet until we heard police in the kitchen. We opened the door and saw two officers in the kitchen who escorted the two of us out through the front doors. END OF STATEMENT
