ACTION TAKEN: On 01/24/13 at 10:25 hours, myself and Detective Michael Downs # 502 conducted a second interview with [REDACTED] 04, a [REDACTED] 04 from Sandy Hook Elementary School. At the time of the shooting [REDACTED] 01 02 03 12, 04 [REDACTED] were in room [REDACTED] 04 [REDACTED] 04 stated that at about 9:30 am, the teachers and students were transitioning between classes. She and [REDACTED] 04 were waiting for another 4 students to show up for class [REDACTED] 01 02 03 12 (was on time) when she heard a banging noise that sounded like a hammer banging on metal coming from the front of the school. [REDACTED] 04 stated that when she heard the banging again, she looked at [REDACTED] 04 and just knew it was bad, but did not know what it was. [REDACTED] 04 stated that [REDACTED] 04 closed the classroom door and they took [REDACTED] 01 02 03 12 into the bathroom and locked the door. [REDACTED] 04 also stated that there were two connecting doors on either side of the classroom that were closed but not locked. [REDACTED] 04 stated that she does not think that the doors lock. [REDACTED] 04 stated that she put her ear against the bathroom wall (a closet in Mrs. D'Amato's room was directly on the other side). [REDACTED] 04 stated that she could hear the shooter talking in the next room and that was when she realized that the shooter was male. [REDACTED] 04 stated that the shooter was cursing "shut the fuck up", "look at me", "You're an asshole", "come over here", and "look at them". Prior to telling us that the shooter spoke, [REDACTED] 04 became upset and told us that she was going to tell us something that she has not told anyone else because she felt we (the police) were the ones she should be saying this to. [REDACTED] 04 described the shooter at this point as evil and that the things he was saying were evil. [REDACTED] 04 stated that she felt that he was in that room for a long time. [REDACTED] 04 stated that she could hear the "banging" and the kids screaming. [REDACTED] 04 stated that some of the screams seemed like they were in another room and not in the room next to them. [REDACTED] 04 stated that she heard the door to her room open hard and heard the apple hit the door (not shake). [REDACTED] 04 stated that near the door is a smart table and she stated that something or someone hit or kicked the table. She knows this because it makes a "boink" noise. ( since the door opens outward, we determined that it was not the classroom door). [REDACTED] 04 described the position of the table near the door and stated that if someone came into the room fast or was unfamiliar with the room, that person would be the one most likely to bump into it. [REDACTED] 04 further stated that after her door opened, she could also hear more shots, only a few and much slower and it sounded like it was in the hallway away from her class. While I was writing the statement, [REDACTED] 04 stated that when she first heard the banging noise, she could hear the noise begin far away from her classroom and she could hear children screaming. Then the noise sounded as if it was coming closer toward her door. She then could hear it in the next room with more children screaming and the shooter talking. [REDACTED] 04 stated that she did not hear any other banging noises, other than the few that sounded like they were in the hallway, after Mrs D'Amato's room. [REDACTED] 04 stated that this led her to believe that the shooter may have gone into Ms. Soto's class first. [REDACTED] 04 stated that when she heard the police next door, she and [REDACTED] 04 came out of the bathroom. She said it was dark and smokey and smelled like natural gas. [REDACTED] 04 stated that she came out of the classroom and Will Chapman (Newtown PD) was there and told them to run to the front of the building. She ran toward the front and that was when she saw that [REDACTED] 01 02 03 12 was being carried out in front of them. [REDACTED] 04 stated that when they got to the parking lot, another officer ran with them to the firehouse and they were the first people there.
