01 02 03 12 was presented with a JD-CR-18, Inventory of Property Seized without a Search Warrant, which she signed, indicating that she had taken possession of her son's personal property, which had been recovered from the school after the shooting on 12/14/12. The items returned to

01 02 03 12 was asked if there was any additional information that 01 02 03 12 had disclosed since the incident on 12/14/12, and she advised that since the incident he had stated that he saw 01 02 03 12 shot first, and ther 01 02 03 12, before he had run out of the classroom. 01 02 03 12 stated that 01 02 03 12 has been consistent with his details about the shooter kicking in the door, and has stated that the children that he ran with were 01 02 03 12 , but knows that there were other kids who also ran, just not in the group with him. 01 02 03 12 stated that 01 02 03 12 had just recently added the detail that when the shooter came in the room, he pointed the gun individually at each person, but didn't say anything to anyone.

01 02 03 12 relayed her new contact information to this Detective, with their 01 02 03 12
