ACTION TAKEN: On 02/04/13 at approximately 0900 hours, Detective Mudry #824 and I met with [redacted] 04 at SHES, at Chalk Hill Elementary School. The purpose of this interview was to clarify information that she provided in her original statement that was given on 12/14/12.

[redacted] 04 stated that she was in room [redacted] 04 with another teacher, [redacted] 04 and [redacted] 01 02 03 12. [redacted] 04 stated that at 9:35 AM, she and [redacted] 01 02 03 12 had just finished picking out a book choice, when she heard a noise. [redacted] 04 stated that she did not know what it was but it was like a "bdddtd" sound. [redacted] 04 stated that she looked at [redacted] 04 and then they heard the same noise again. [redacted] 04 stated that she just knew that the noise was not good. [redacted] 04 stated that she went to the door to close it and saw [redacted] 04, another teacher, across the hall. [redacted] 04 stated that they looked at each other and knew to shut the doors (like in a lock down). [redacted] 04 stated that she did and went with [redacted] 01 02 03 12, [redacted] 04 to the bathroom. [redacted] 04 stated that [redacted] 04 was up against the wall closest to Mrs. D'Amato's room and she was by the door. [redacted] 04 stated that she heard an adult woman scream and then she heard the "bdddtd" noise and she kept hearing it and hearing it. It (the noise) was getting closer and closer. [redacted] 04 stated that she did not hear it get further away from them, just closer. [redacted] 04 stated that she could hear little screams. She heard scream, scream, scream, and then nothing, not even a single shot. [redacted] 04 stated that (she clarified that it was at some point) she heard the door to the class open because she heard the apple hit the door with force. [redacted] 04 stated that she also heard something hit the smart table, like the connecting door but with the time issue, it could have been a police officer. [redacted] 04 stated that after the police came, they went to the door and asked the officer ( identified by [redacted] 04 in her statement as Will Chapman, Newtown PD) standing there if they could leave. [redacted] 04 stated that he told them to go and as they tiptoed their way down the hallway, there were cops moving with their guns drawn. [redacted] 04 stated that they told [redacted] 01 02 03 12 to look down and [redacted] 04 stated that she looked straight ahead. They did see a police officer carrying out a little boy in front of them and she saw the principle and school psychologist lying on the floor. [redacted] 04 stated that she believes [redacted] 04 looked into a classroom. [redacted] 04 stated that they ran into the parking lot and were met by another officer who directed them to the firehouse. [redacted] 04 stated that they were the first ones there because the building had to be unlocked for them. [redacted] 04 stated that the connecting doors in the room were not locked because she knew D'Amato's room had a substitute and they told her that if she needed anything to just come into their room. [redacted] 04 also stated that [redacted] 04 told her that she heard things (that the shooter said things) during the shooting when they were in the bathroom. [redacted] 04 stated that she and [redacted] 04 never discussed what she heard. [redacted] 04 stated that she did not hear anything while the shooting was going on and getting closer to them, she stated that she was thinking about everyone in that hallway being shot and kept thinking that they were next and she may have blocked it out. During the interview, [04] mentioned that she knew that the time was 9:35 AM because she looked at the clock and not everyone's clock at the school is the same. [04] also remarked to us that the day felt different. She stated that there were a lot of staff absent and therefore everything got thrown off with the substitutes. [04] stated that for some reason the kids were late for her class. There were events going on in the school that would have brought parents to the school. [04] stated that if the day went like it should have gone, that hallway would have been filled with a lot of people at the time of the shooting.

CASE STATUS: This case will remain active pending further investigation.
