At this point 04 told us all to move to locked the door and called the Police. 04 then put a piece of white paper over the window so that 01 02 03 12 said that his classroom is in the back of the school and 01 02 03 12 is in the front of the school	o the back corner of the room and she no one could see into the classroom.

said that he heard giant thumping like bigfoot was crushing the school and then we heard a woman scream "don't shoot" over the loudspeaker which was turned "on".

O4 then yelled "don't shoot". A little while later the Police knocked on our door and got us to the Firehouse.
