04 related that in January of 2012, she started working at the Sandy Hook Elementary School as a 04

That on December 14, 2012 at approximately 10:00 A.M., she arrived at Sandy Hook Elementary School and observed several police and ambulance vehicles in the driveway. 04 stated that very soon after she arrived, she observed two children and one injured teacher being carried out of the school and loaded into ambulances. 04 stated that she then backed her vehicle down the driveway and parked at the Sandy Hook Fire House. Once at the fire house, 04 stated that she helped escort children into the fire house or to their parents.

Lastly, 04 related that she was never able to enter the school and that she proceeded home at approximately 2:15 P.M.
